

**ORDINANCE NO. 2023-22**

**AN ORDINANCE AMENDING THE FERDINAND MUNICIPAL  
CODE REGARDING PARK LEASES AND FEES**

**WHEREAS**, the Town charges a fee for reserved exclusive use of park facilities;  
and

**WHEREAS**, it is the recommendation of the Ferdinand Park Board that the fee  
for the exclusive use of the 18<sup>th</sup> St. or 5<sup>th</sup> St. Park be increased to \$500.00 per day; and

**WHEREAS**, the State Board of Accounts wishes this fee be set by Ordinance.

**NOW THEREFORE, BE IT ORDAINED:**

1. Ferdinand Municipal Code Section 1.06.070 Fees is amended as follows:

**“1.06.070 Fees.** The Board may authorize use of specific park facilities  
pursuant to terms, conditions and regulations as established from time to  
time by the Board, and for the fees as hereinafter set forth:

| (8) 5 <sup>th</sup> St. Shelter House  | \$ 50.00 per day |
| (9) Old Town Lake Shelter House  | \$ 50.00 per day |


The Board is authorized to enter into leases from time to time for multi-  
facility and multi-date use for fees the Board considers appropriate  
considering the length and nature of the use and which may combine  
fields and shelter houses or use of all park facilities on one or more  
dates.”


2. All other provisions of Chapter 1.06 shall remain unchanged. The  
Clerk-Treasurer shall cause this Ordinance to be published as required  
by law. This Ordinance shall be effective January 1, 2024, upon  
adoption and publication as required by law for the 2024 leases and  
thereafter.
