We will have renowned, nationally-touring musicians and numerous workshops as well as wonderful activities for children. We also again welcome a vibrant diversity of art and food vendors and environmental/wellness education exhibits.

The Ferdinand Folk Festival will be highly advertised locally and in the Evansville, Louisville, Bloomington, and Indianapolis markets. We anticipate a large, diverse crowd. ART/ARTISAN MARKET VENDORS: The festival committee requests that you sell local and regional hand-created items made by the vendor—works featuring the unique talents of area artists. All booth and table rental fees will be required with this application. After payment is received, if you must cancel, there will be **no refunds** and **no credit** toward a future event. All booths are outdoors in the park. **This** event will take place rain or shine. Set-up time is Saturday, September 21, 7:00 am - 10:30 am. If you would like to set up your tent/awning Friday evening (Sept. 20), booth spots will be marked for your convenience.
